Addendum

Subsequent to the writing of this chapter, ASHA (American-Speech-Language and Hearing Association) Ad Hoc Committee on Childhood Apraxia of Speech, published a draft Position Statement and Technical Report in February 2006. The committee was set up in 2002 and undertook narrative reviews of peer-reviewed literature published in the past 10 years with additional sources consulted as needed for coverage of certain topics.

Following extensive peer-review by researchers and clinicians, the committee published a second draft of the Position statement and Technical report in November 2006. The finalised versions are still awaited at the time of writing (March 2007). Readers are directed to the ASHA website for further information. A summary of the key findings from the 2nd draft of the Position Statement is included after the Appendix for our readers' information.
